CARE BEGAN TO TRANSITION THEIR LARGE-SCALE NURSE MENTORING PROGRAM FROM A CADRE OF BSC TRAINED NURSES ORIGINATING OUTSIDE OF BIHAR TO A CADRE OF AUXILIARY NURSE MIDWIVES (ANMS) AND GENERAL NURSE MIDWIVES (GNMS) WORKING WITHIN THE BIHAR HEALTH SYSTEM DUBBED AMANAT JYOTI.
