Following the closure of USAID and the resulting disruption to the global health funding landscape, PRONTO dedicated significant time this year to strategic planning. This included developing a deeper understanding of the shifting funding environment, pursuing new institutional and funding partnerships, and advancing curriculum development for the U.S. market through the expansion of FRONTIER, our curriculum addressing obstetric and neonatal emergencies in maternity deserts.

Building on findings from Aim 1, PRONTO is helping to develop a comprehensive training package (Aim 2) that includes high-fidelity simulations, teamwork and communication exercises, and case-based learning to address stigma, bias, and respectful care. PRONTO Master Trainers-experienced across both U.S. and global settings-are facilitating a set of sessions for rural hospital clinic champions. PRONTO also supplies all simulation materials, including PartoPants and PRONTOPacks. Collaborating with the Northern New England Perinatal Quality Improvement Network, the STONE program, Dartmouth Hitchcock, and the University of Utah's LIFT Lab, PRONTO adapted its PRONTOSat curriculum and built a train-the-trainer package for EMS and Emergency Department teams responding to maternal and neonatal emergencies in maternity deserts. PRONTO co-designed the training with local partners and facilitated an interprofessional training in Concord, NH. An additional set of trainings and curriculum development activities were completed in 2024-25.
